For example: HALO, PSH Renewal Application. HUD requires all applications to be submitted at least 30 days prior to full application due date.
Saturday, September 10, 2022, by 11:59:59 PM CST	Selection & Prioritization Decision Notification to Agencies	Leadership Council will review Rating and Ranking recommendations. Applicants will be notified by email no later than this date and time that the application was accepted, rejected, reduced, or increased.
Tuesday, September 13, 2022, by 08:00:00 AM CST	Appeal Deadline	Appeal submission due by this date to racinecocorg@gmail.com (use subject line: "Agency Name" Grant Appeal). Appeals include involuntary reduction/reallocation, project selection, and prioritization.
Thursday, September 15, 2022, by 8:00:00 AM CST	Appeal Decision Notification	Deadline for agencies to be notified regarding appeal decisions. Notification of decision will be sent to applicant via email by September 15, 2022, by 8:00:00 AM CST
Thursday, September 15, 2022, by 11:59:59 PM CST	Final CoC Notification to All Projects Outside of e-snaps	Final selection of projects for inclusion in application and prioritization. Notification of acceptance or rejection will be sent to applicant via email and posted on the CoC website by September 15, 2022 - (HUD requires public notification of project acceptance, rejection, priority 15 days before HUD submittal deadline.)
Tuesday, September 20, 2022, by 11:59:59 PM CST Revised: Wednesday, September 28, 2022, by 4:00:00 PM CST	Final New, Bonus & Renewal Project Applications Due in e-snaps	Last date for any modifications/corrections to applications and resubmittal in e-snaps after rating and ranking final appeals and threshold reviews. Submit copy of final e-snaps version as pdf to racinecocorg@gmail.com (use subject line: "Agency Name" Final e-snaps Copy)

By Friday, September 30, 2022, 7:00 PM CST	Submission of FY22 CoC Consolidated Application	Official due date is September 30, 2022, 08:00 PM EST (07:00 PM CST)
